International Handling Tariff



1.- Air freight shipment – CPH Airport

Basic service charge (inbound / outbound):

From free arrival at Copenhagen airport up to DSV warehouse upto 500 kgs (above kgs ask for special prices), or vice versa.	2.50.-€ / kg (min. 150 kgs)
From DSV advanced warehouse up to delivered to stand at Bella Centre	Check paragraph 2.

For individual pieces not exceeding either 800 kg or 200x100x200 cm in dimension.

(1 cbm = 300 kgs - based on actual or volumetric weight, whichever is greater).

Not included in the a.m.: airline arrival charges, possible storage fees at the airport and handover charges to the airline (cession), +15% disbursement fees min. 50.-€.



2.- Road freight shipment via warehouse

Basic onsite handling charge (inbound / outbound) - (all the exhibits must be shipped to our warehouse; direct deliveries are not permitted):

From DSV advanced warehouse up to delivered to one stand at Bella Centre, or vice versa. Shipments upto 100 kgs.	225.-€
Additional per each 100 kgs or part off	35.-€.

Each started cbm counts as full cbm. For individual pieces not exceeding either 800 kg or 200x100x200 cm in dimension.

(1 cbm = 300 kgs - based on actual or volumetric weight, whichever is greater).

All services are handled with 2,5 ton forklifts.

Exhibit shipments must be sent to DSV advanced warehouse. Direct deliveries to the venue or stand are not permitted only for stand building materials.



3.- Courier shipment via warehouse

Basic onsite handling charge (inbound / outbound) - (all the exhibits must be shipped to our warehouse; direct deliveries are not permitted):

From DSV advanced warehouse up to delivered to stand at Bella Centre, or vice versa. Shipments upto 25 kgs.	135.-€
Shipment above 25 kg.	Will be treated as road freight cargo.
Customs clearance and other charges.	As per current tariff.

(1 cbm = 300 kg - based on actual or volumetric weight, whichever is greater).

Not included in the a.m.: courier arrival charges, possible storage fees and handover charges to the courier company (cession), +15% disbursement fees min. 50.-€.

Courier companies cannot do the customs clearance of shipments for events or exhibitions as they need an importer with a Danish ID. Please avoid sending cargo with them. In case you send cargo through courier companies get in touch with us in advance.

We highly recommend sending your courier shipments to our warehouse address under CFR DSV warehouse conditions (not DDP). This way you ensure your items arrive safely and on time. In that case DSV will arrange customs clearance; therefore, we need a complete set of documents as mentioned in the shipping manual.



4.- Direct unloading & reloading

Basic onsite handling charge (inbound / outbound): (only stand building material):

Vehicles upto 7 ldm (one stand)	750.-€
Vehicles upto 13.6 ldm (one stand)	1.250.-€
Multiple deliveries to other stands	125.-€ / stand

Booking service min. 2 weeks before the service is required. Freight must be palletized.

All services are handled with 2,5 ton forklifts. Contact us for 5 ton & 8 ton forklifts.

DSV will provide any technical equipment required.

Please remember it is not allowed to use your own equipment inside the hall: forklift, electric hand pallet or scissor lift.

Exhibit shipments must be sent to DSV advanced warehouse. Direct deliveries to the venue or stand are not permitted only for stand building materials.



5.- Assembling & dismantling

6.- Storage

Empty storage. (Minimum per exhibitor: 2 cbm).	85.-€ / cbm.
Full storage (tools, ladders, hand pallet or full products). (Minimum per exhibitor: 2 cbm).	115.-€ / cbm.
Accessible storage (Minimum per exhibitor: 2 cbm).	155.-€ / cbm.

Each started cbm counts as full cbm. The above services are per exhibitor.

Attention! Empty cases must be empty. We do not accept any responsibility for articles inside of boxes that have been declared as empty cases.

We understand full storage, with independence as labeled: tools, genies, ladders, and hand pallets. For other material or valuable goods please inform us in advance to inform you how to proceed or if any additional cost might incur.

***** Empty cases & full goods for storage picked up after official buildup period will have a surcharge of 75%.**

***** Empty cases & full goods for storage picked up at opening day will have a surcharge of 100%.**

Attention!! Please consider 2 hours between the exhibition closing time and the start of empty cases & full goods delivery.



7.- Customs clearance

ATA Carnet safekeeping.	60.-€ / document.
Temporary entry with invoice (1 hs codes incl.) (Only if approved by DSV) (*).	300.-€ / clearance. Additional HS code: 25.-€
Bond fee temporary entry (commercial invoice).	2% CIF value (min. 200.-€).
Permanent import (up to 15.000,00 €) / export. ** Brochures & merchandising. For other products please check in advance to review it. (1 hs codes incl.)	205.-€ / clearance. Additional HS code: 25.-€
Permanent import (above 15.000,00 €) / export. ** Brochures & merchandising. For other products please check in advance to review it.	Upon request.
Duties & taxes per outlay.	+15% commission (min. 25.-€).
Customs Inspections (*Mandatory for re.export of temporary goods).	225.-€.
Fines.	Outlay +15%.
Cancellation of transit documents at DSV warehouse (1 hs codes incl.).	165.-€ / document. Additional HS code: 25.-€
Issuance of transit document at DSV warehouse (1 hs codes incl.).	165.-€ / document. Additional HS code: 25.-€

(*) A full liability deposit, for Danish Duty & VAT, may be required in advance of movement. The deposit will be refunded once the T-doc has been confirmed as discharged by local Customs.

Remind you cannot remove any freight from stand under temporary entry. DSV needs to close the guarantee with Customs Authorities and freight should be transferred to our bonded warehouse and DSV will arrange the return transport.
